Privacy Notice

The Department of Education and Training is collecting your personal information on this form in order to obtain consent for disclosure of a student's personal information to facilitate registration and use of third party web based software identified on the form. The information will be used and disclosed by authorised school employees for the purposes outlined on the form.

Student personal information collected on this may also be used or disclosed to third parties where authorised or required by law. This information will be stored securely. If you wish to access or correct any of the personal information on this form or discuss how it has been dealt with, please contact your student's school in the first instance.

Dear Parents and Guardians,

The use of web based educational resources has risen steadily over the last decade. Teachers are increasingly using these resources across Queensland to improve student- learning outcomes.

Our school and teachers make educational decisions about effective eLearning experiences, meeting student needs. Education Queensland provides most resourcing we use at school, however occasionally a third party web based provider is required.

Our school wishes to utilise the following third party web based service providers, to aid students learning; SeeSaw. For your child to use these services, their teacher will need to register them as a user. Registering with these providers requires student personal information to be disclosed to the provider of the service. Registration may include disclosing the following information about your student:

- Student Name (First Name ONLY)
- Year group
- Class Teacher and
- Student Education Queensland email address

In the case of the services outlined below they are private companies that are hosted onshore in Australia and/or outside of Australia. Outside of Australia means that data entered to register for these sites will be stored on servers that are not based in Australia and therefore are not bound by Queensland's privacy laws.

We need your permission for the registration and use of these sites by your child. Please complete the consent form below and return it to your child's classroom teacher.

Note: It is not compulsory for you to provide this consent- If you decide not to provide consent, this will not adversely affect academic achievement, or any relationships with teachers or the school.

Before you complete this consent form it is important that you understand the reasons that these websites collect this information, what will be done with it, who may have access to it and where the data is stored. This information can be found in the hyperlinks below referring to each website's terms and conditions and/or privacy policy.

Please read these and ensure that you understand the implications of using these services before giving your consent. If you have any queries around the storage of student's information, please contact the Principal. Please note that given the significance that these services provide, the school will contact you to discuss your reasons should you not consent or fail to provide a response.
